Emerging Issues Policy Forum

Dr. Mark Jamison delivered the presentation, **Restructuring U.S. Networking**, at Amelia Island, FL to 100 U.S. regulators and industry officials in attendance. He explained how traditional views of mergers were inappropriate for the pending mergers of SBC-AT&T, Sprint-Nextel, and Qwest or Verizon with MCI. Communications markets are evolving rapidly, which makes it difficult, if not impossible, to assess market power or market concentration. He benchmarked U.S. companies against their international rivals and found that currently U.S. firms are behind their Asian rivals in terms of innovations in mobile communications and are in the middle of the pack in terms of developing extensive networks. The pending mergers, if completed, would help rectify these problems.

National Association of Regulatory Utility Commissioners Winter Meeting

Dr. Mark Jamison delivered the presentation, <u>Competition in Mobile Communications</u>, to the NARUC Committee on Consumer Affairs to 50 regulatory commissioners, staff and others in attendance. He examined the competitiveness of the U.S. cellular markets and benchmarked the U.S. markets against other countries' markets in terms of market concentration, numbers of operators, customer usage, and price. The evidence indicated that the U.S. market is more competitive and provides greater customer benefits than do most foreign markets.
